GENERAL DUTIES:

Under general supervision, has sufficient understanding and experience to operate in a broad range of moderate to difficult professional casework involving predominately moderate-high risk clients on pretrial, presentence, probation, parole or residential. Develops quality working relationships and is a change agent when working with clients. Performs related work as required. Facilitates educational and cognitive behavioral groups.

QUALIFICATIONS:

Graduation from a four-year accredited college or university; or graduation from an accredited two-year or a minimum of 60 credit hours at an accredited college or university and two years human services/criminal justice experience; or an equivalent combination of related education and/or human service/criminal justice experience to equal four years.

Preferred: Degree in Criminology, Social Work, Human Services, Behavioral Sciences, Sociology, or Psychology and/or correctional experience. **Broad knowledge and understanding of correctional research, principles of effective correctional interventions, and the adult criminal justice system.**

NECESSARY SPECIAL REQUIREMENTS:

Barring reasonable accommodation under the American with Disabilities Act, designated positions in this job class require applicants to possess, obtain and maintain a valid driver's license, and the ability to be insured and maintain insurability under the district's auto insurance coverage.
