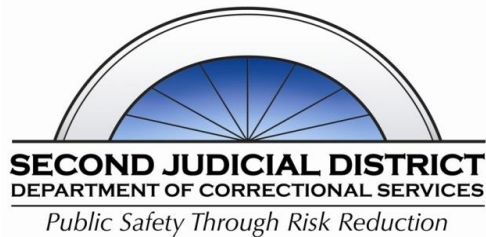
This is our second meeting at new location. We will meet in the basement of the courthouse. The steps to basement or elevators are located inside the front doors.
